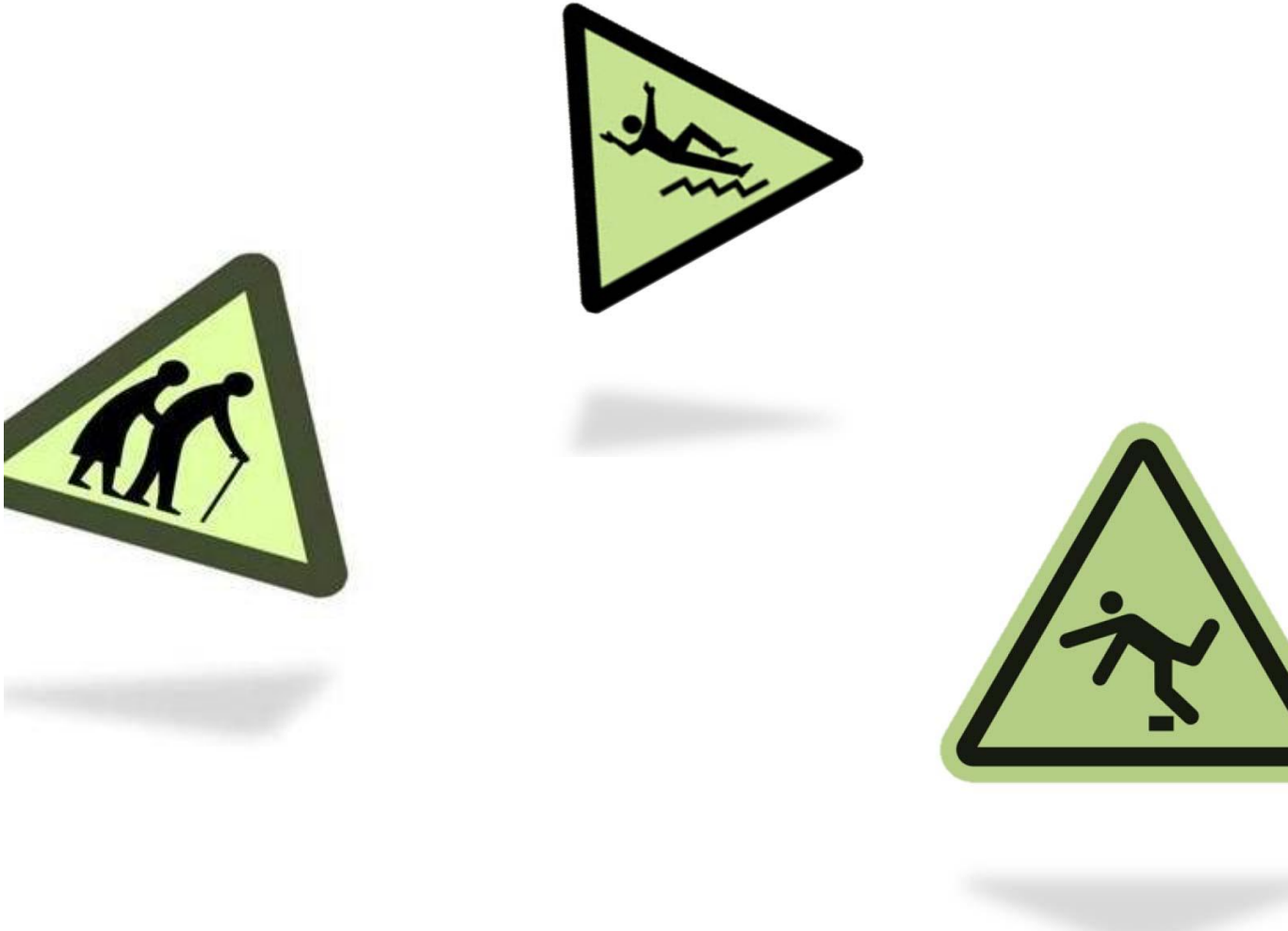



- Communicating the promotion of the health & safety of employees which is paramount and contributes to the success of the business.
- Ensuring that the Company will take all reasonable measures to protect the health and safety of employees and all others who may be affected by our activities.
- Continually improving its Occupational Health & Safety Management System and company performance in Health and Safety.
- Our Health and Safety Policy is monitored and reviewed to ensure that it meets the companies' legislative requirements, Health & Safety objectives and targets and remains relevant and effective to the changing needs of our business and customers.
